Age relaxation will be given to those candidates who have experience in conducting field survey and field data collection work in a Government Organisation, for the number of years served in it, as also to Candidates belonging to SC/ST/OBC Categories or Candidates with disabilities or Ex-servicemen as per the GOIs Instructions in vogue.
- (iv) Reservation/Relaxation:- In respect of SC/ST/OBC candidates as also Candidates with disabilities or Ex- servicemen, according to Govt. of India's Instructions in vogue (First priority may be given to Eligible Ex-servicemen in respective categories (including General Category)).
- (v) Nature of Duties: The Field Investigators are required to do field surveys of NSSO to be conducted in rural and urban areas. The duties involve extensive touring within the assigned geographical areas.
