To encourage young students/researchers to make career in emerging areas of earth sciences the Institute also undertake sponsored projects. Position: Junior Research Fellow (02 Positions)

Essential Qualification : 1st class M.Sc./M.Tech in Geology/Applied Geology/Earth sciences.

Project Tenure : Three Years

Emoluments :

For CSIR-UGC NET-JRF/GATE qualified candidates:-

Rs. 25,000/- p.m. consolidated + admissible HRA initially for two years, and during subsequent year/s as SRF a consolidated sum of Rs. 28,000/- p.m. + admissible HRA.

For non-CSIR UGC NET-JRF qualified candidates:-

Knowledge of Geology of North East India.

Preference will be given to candidates who have qualified NET/GATE, UGC-CSIR combined examination. In case suitable NET/GATE, UGC-CSIR qualified candidates are not available Non-NET qualified candidate will also be considered.
