# DETAILS OF TERMS AND CONDITIONS, QUALIFICATIONS AND EXPERIENCE

#### Minimum Qualification and Experience as per A.I.C.T.E. norms.

#### PROFESSOR, ASSOCIATE PROFESSOR, ASSISTANT PROFESSOR:

Candidates assigned to these posts shall perform similar functions such as, teaching, research, extension, continuing education, scientific & industrial consultancy and others, which may be assigned to them by the Institute from time to time. They may also be delegated certain administrative and/or other functions/responsibilities at the Institute. The status, perks, service conditions and responsibilities of Professor, Associate Professor, Assistant Professor and others if any, shall be as per decisions of the Board in accordance to the norms of the Institute.

#### **Deputy LIBRARIAN:**

The person occupying this post shall be in charge of the Central Library of the Institute and be responsible for its planning, development, up-gradation, maintenance and administration. The service conditions and responsibilities of a Librarian shall be as per decisions of the Board. The appointing authority shall be as per the pay scale.

- (ii) Evidence of post- Ph.D. research experience and ability to pursue high quality academic/research work independently, which includes having guided Ph.D.;
- (iii) Good publications record in refereed scientific/professional journals with citations; patents to be given priority
- (iv) Age: < 55 Years

#### Desirable Qualification:

- (i) Evidence of having taken up sponsored research, continuing education and/or industrial consultancy;
- (ii) Proven record of academic/research leadership, guiding UG/PG and Ph.D. students and team work
- (iii) Participation in professional society activities;
- (iv) Good knowledge of technical education system in the country and its development;
- (v) Consultancy and other methods of fund raising for the Institute shall be preferred.

## ASSOCIATE PROFESSOR: who fulfils the minimum requirements of Assistant professor and

- Essential Qualification:
  - (i) Ph.D. degree from reputed university.
  - (ii) Teaching/Research/Industrial experience in the relevant discipline for a minimum of 08 years; which does not include the period of Ph.D. and M. Tech. if done as regular candidate. PDF and other higher qualification shall be given preference
  - (iii) Evidence of ability to pursue high quality academic/research work independently;
  - (iv) Good publications record in refereed scientific/professional journals with citations; patents to be given priority; paid journals will not be considered;
  - (v) Age < 50 Years
- <u>Desirable Qualification:</u>
  - (i) Evidence of having taken up sponsored research, continuing education and/or industrial consultancy;
  - (ii) Proven record of guiding UG/PG and Ph.D. students and team work
  - (iii) Participation in professional society activities; and organization of conferences and seminars.

## ASSISTANT PROFESSOR: AGP 6000

- Essential Qualification:
  - (i) B.E./B.Tech/equivalent and M.E./M Tech. in the concerned discipline with a First Class at either level. All degrees to be from courses approved by AICTE/MHRD
  - (ii) Age <35 years on the last date of receiving application.

## Desirable Qualification:

- (i) GATE qualification shall be given weightage;
- (ii) Teaching/Research/Industrial experience in the relevant discipline;
- (iii) Publications record in refereed scientific/ professional journals.

# ASSISTANT PROFESSOR IN ALLIED SCIENCE AND HUMANITIES:

## AGP 6000

- Essential Qualification:
  - (i) Ph.D. with course work or as per UGC guidelines along with NET/SLET or any equivalent exam passed. Board may adopt the guidelines of UGC at the time of advertisement
  - (ii) M.Sc. in the concerned discipline preceded by B.Sc./equivalent with a First Class or Good Second. All degrees to be from courses approved by UGC
  - (iii) Age <35 years on the last date of receiving application. The age may be relaxed by director with the permission of Board for deserving candidates.

Desirable Qualification:

- (i) Publications record in refereed scientific/ professional journals.
- (ii) Teaching/Research/Industrial experience in reputed organization;

#### NOTE:

- 1. The qualifications and other criteria in the above mentioned faculty positions are minimum. The screening committee may raise the minimum criteria to ensure that meritorious candidates are recruited.
- 2. Degrees from IITs and other Institutes of National Importance (as defined by the Govt.) shall ordinarily be preferred over other institutes.

  - (ii) Service experience as Assistant Librarian at a reputed institute for a minimum of 05 years;
  - (iii) Age < 45 years on the last date of receiving application.
- Desirable Qualification:
  - (i) Knowledge of computers, internet and other recent advances in library operation and management.
  - (ii) Ph.D. in Library Science;
  - (iii) Publication in the relevant area
